7. Landmarks

a) Dawn Lumber Company Mill - Sierra National Forest

Notice was received that an application for National Register historic status was denied because the mill did not fit the National Register's criteria. Chairman McFarland thinks the mill is worthy of consideration for placement on the local register since the local criteria is not as strict. Mrs. Bosch Cobb offered to contact the applicants to make them aware of the local register. Mrs. Enloe will provide Mrs. Bosch Cobb the name of the individual who has been working on an oral history program about the Sierra National Forest area.

- b) Inventory of Historic Sites in Fresno County
 - 1) Pending Applications Action Needed a) Velasco House, 20931 S. Kingston, Laton On September 14, 2006 the Commission approved submission of this application to the Board of Supervisors pending receipt of additional information from the applicant. Mrs. Velasco provided a verbal update, and she said she has additional photos on a CD. Mrs. Bosch Cobb and Mrs. Velasco will get together to work on gathering some of the missing information, and the application will be brought back for review in January.

- a) Update on Del Rey Historic Properties Commissioner Taylor distributed a set of maps pinpointing the properties he is researching. He is also continuing to work on gathering information and completing the applications.

An updated version of the inventory will be distributed at the next meeting. Mr. Bill Secrest, Jr., researched the addresses where the information about the city had been left out.

Commissioners considered how to make corrections to the inventory. The Jensen Home in Selma is on the list twice--#131 and #140. Some properties on the list have burned; the Vincent house was moved. There are also some typographical errors.

There was also discussion about adding a historic preservation ordinance to the County's General Plan. Ms. Bos thinks it is crucial to approach the cities about adopting historic preservation plans, and she is personally planning on approaching the City of Clovis. Ms. Rehart suggested conducting workshops, inviting historical societies, and publicizing the workshops in local newspapers. Ms. Bos added that the City of Fresno has an excellent ordinance that could be duplicated rather than trying to recreate one. Next spring was suggested as a good time to hold the workshop.
