AGENDA ITEMS

- 1. The meeting was called to order by Chairman Randy McFarland .
- 2. Adoption of Agenda: The order of the agenda was revised. Item 9 b) 1) Gefvert Ranch was moved to follow item 6.
- Comments from the Public: None.
- 4. Approval of Minutes of September 20, 2007: The minutes were approved as distributed.
- 5. California History & Genealogy Room Acquisitions Mr. Bill Secrest Jr., the California History & Genealogy Room Librarian, shared some recent acquisitions with the Commission. The items he brought to the meeting were a 1918 photo of young men going to war (women and children were also in the photo) taken in front of the Civic Auditorium that was located where the Del Webb building (County Plaza) currently sits, two books on the subject of mineral resources west of the Rockies in 1850/51 at a time when gold mining no longer existed in Fresno County, an original print of a chapter decoration of William Saroyan's <u>A Human Comedy</u>, and a photo of the Fresno Fire Department in 1877 right after it was organized.

- Centennial Farms

Gefvert Ranch (Sheldon Family Residence) – Commissioners reviewed an application submitted by Mrs. Madeline Sheldon to place her family's residence on the County's list of historic places. Mrs. Sheldon provided the following information.

- ✓ The Gefvert's came from Sweden in the 1800's and immigrated to Minnesota, and moved to Fresno due to health reasons.
- ✓ Mrs. Sheldon is the granddaughter of Ben Gefvert.
- ✓ Thompson grapes, Washington navel oranges and almonds are grown on the farm, and the farm has been in operation by the same family over 100 years.
- ✓ Mrs. Sheldon wants to preserve the Queen Anne palms located on the property. Queen Anne palms are a variety of palm trees that were popular in the Victorian era.
- ✓ The Highway 180 project threatens to cut the farm in half. Caltrans is projecting the 180 extension will probably take another 10 years. The current construction ends on Brawley and Whitesbridge.
- ✓ Theodore Kearney and Ben Gefvert were friends, and Mr. Kearney sometimes visited the house.

Based on the information above, Commissioners suggested that Mrs. Sheldon provide two applications; one to place the property on the list of Centennial Farms and the other to place the property on the List of Historic Places. There was some discussion about checking with Caltrans to add to the historical information on the application. This application was continued to the next meeting.

8. Report from Subcommittee to consider establishing a Centennial Cities or Communities Component

The subcommittee is continuing to work on this project. They are gathering information that includes other names, dates of establishment of ferry, railroad, post office, and the community recognized founding date.

 Mr. Bill Secrest Jr. researching records to provide the information that is still outstanding.

 a) Fresno County Hall of Records Update A professional photographer was hired to take photos for the application in the format required by the State of California. Mr. John Powell is working with Mr. Bill Secrest Jr. to write the narrative.

 a) Arco Garage Mrs. Bosch Cobb gave a historical overview of the garage. In
 January 2005 the Board of Supervisors approved the sale of the garage to the
 Fresno City & County Historical Society. The Society planned to preserve the
 building and use it for parking for the Downtown Club, but those plans fell
 through. The Society's new partners for the project are Mr. Chris Johnson and
 Mr. Bruce Owdom.

Mr. John Navarette wants to meet with the Historical Society before the Commission considers the garage for the List of Historic Places. Commissioners Taylor and Pappas, Mrs. Bosch Cobb, Ms. Jill Moffat, Mr. Bruce Owdom, and Mr. Chris Johnson will be invited to the meeting. Mr. Johnson is the architect who restored the train station.

- c) Discussion of threatened buildings in downtown Fresno The new owners of the Fresno Hotel contacted Ms. Laval for photos of the original interior to design a historically accurate lobby. Mr. Barile commented about Mr. Chris Johnson's interview on KVPR regarding his involvement with the restoration of the Virginia Hotel.
