1) Call to Order at 4:05 PM. Raman Bath, County Librarian

2) Welcome & Introductions.

A) Welcome and Introductions. Raman introduced Jean Rousseau County Administrative Officer and Mike Counts who is presenting application

3) Adoption of Agenda.

A) Adopted with correction to 7B additions. Pappas; Second: Catallo. Passed Unanimously.



- **4) Approval of Minutes**: Motion to adopt minutes of March 18, 2021. Pappas; Second: Zech. Passed Unanimously.
- 5) Public Comment. Jean Rousseau thanked Commissioner Zech for his presentation this last week on the Reed Ranch in Reedley. The CAO has discussed with the Board of Supervisors that he would like to see the HLRC presented at the Board annually. This would allow the Board to recognize the work that the Commission does for the County. He left it up to the Commission to decide when they thought it would be best. The Commission decided that the first week in May is National Preservation Week and that would be a good week to coincide. There will be a resolution for the Commission. Raman and Karen will work with the Commission to discuss plans for upcoming year.

6) Landmarks:

- A) Inventory of Historic Sites in Fresno County.
 - i) Commissioner Pappas went over the list that was inside the commissions packet of all 347 sites. Commissioner Pappas will provide the full list of individual sites at the next meeting and it also on the website. There was a request to change Church, to Place of Worship.
- B) Historic Places: Discussion and Necessary Action:
 - The application for the William Micka Residence was presented by Mike Counts and reviewed by the commission. It was presented on the value and quality of the architecture and design of the 1950's. Mike Counts who presented it gave a background on the international style and explained the importance of the recognition in the County. It is considered Modernism Architecture and the Commission have none on their list. The Selland Arena as well as the Old Guarantee building at Blackstone and Ashlan are both of this style, Mike has no idea on how many homes are in Fresno of this style. Mike included how important it would be for the architects themselves to have recognition. The home on the application has not been altered. Commissioner Pappas explained that she would like to see more depth of the application when presenting it to the Board of Supervisors as well as how important it is for archive purpose and research. The commission requested more pictures of different perspectives and more background on that type of architecture and why it is significant to the County of Fresno. The home has only had 3 owners, with Mike being the present. He does have a full set of plans to the home. Commissioner Lloyd, spoke of a list to include other buildings of this type of architecture. Commissioner Zech thought more biographical on William Micka the first owner would be helpful as well. The commission offered help with the requests they had ask for. Commissioner Pappas and Mike Counts will be working on revising the application and bring it back for review.

 - (1) Commissioner Yovino gave update on Sunnyside Country Club and their Board has reviewed our application process. At this time, they are not interested in pursuing an application, possibly due to restrictions they felt might be put on the club. The CAO offered to follow up as well on this, as it is just a recognition and nothing more.
